I have the honour to report on the collaborative programme between the Government of Mexico and the Inter-American Committee against Terrorism (CICTE) of the Organization of American States for the physical protection and control of chemical, biological, radiological and nuclear material in support of the implementation of United Nations Security Council resolution 1540 (2004). As you know, this programme benefits from the technical support of the Group of Experts from the 1540 Committee and the United Nations Office for Disarmament Affairs, strategic partners of CICTE. 12-44047E

I wish to report that following various consultations between the Mexican authorities and CICTE, notably the Special High-Level Committee on International Disarmament, Terrorism and Security (CANDESTI), the parties concluded and agreed to the Comprehensive Training Plan (see annex).

I would like to reiterate our country's intention to carry out the aforementioned collaborative programme, in coordination with CICTE and its strategic partners, and to solicit support from the States members of the Committee, through the cooperation platform of this subsidiary body of the United Nations Security Council, in order to obtain resources to fund and execute the programme.

In this regard, I wish to request the support of the Committee in identifying, through its cooperation platform, States or organizations that could possibly provide resources or expertise to implement the Plan. The Government of Mexico places high priority on international cooperation activities, and will thus make the necessary efforts to implement the programme fully, with the primary goal of strengthening national non-proliferation capacities.
